15. To review, discuss and take action on any needed maintenance or replacements of the District's equipment, apparatus and facilities.
16. Review and take action on District personnel matters.
17. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.

To discuss any new items which need to be on the agenda for the subsequent District meetings and approve the proposed meeting dates for the bill pay meeting to be held on Wednesday, November 6, 2019 at 6:30 p.m., and the regular monthly meeting to be held on Tuesday, November 19, 2019 at 7:00 p.m.

To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.

21. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
22. Review and take action on District real estate matters and personnel matters discussed in closed session.
